#### **TSDA Spending Policy**

(Amended October 16, 2024)

The TSDA shall make funds available for special projects and programs that support the mission of the Association. When the investment portfolio has a corpus value of at least \$1 million, TSDA will calculate the amount available under spending policy for the upcoming budget year to be 4% of the monthly average of the investment portfolio balance from October 1 of the previous year to September 30 of the current year. The resulting amount shall be made available to fund approved projects and programs in the following calendar year. These funds shall be apart from regular TSDA operations. Only TSDA-member or internal TSDA projects and programs will be considered and awarded funds through this spending policy to support cardiothoracic surgery educational endeavors that benefit trainees and educators. Recipients are required to acknowledge the TSDA for providing this financial support.
